ARTICLES

2. Shall the School District raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein, totaling Seventy-Six Million Six Hundred Four Thousand, Nine Hundred Forty-Five Dollars and Ninety-Nine Cents (\$76,604,945.99)? Should this article be defeated, the 2011-2012 operating budget shall be Eighty-One Million, Five Hundred Twenty-Five Thousand, Five Hundred and Ninety-Nine Dollars and Forty Cents, (\$81,525,599.40), which is the same as last year with certain adjustments required by previous action of the School District or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X, and XVI, to take up the issue of a revised operating budget only. (Recommended By The Derry School Board)

Shall the School District approve the cost items included in the collective bargaining agreement reached between the Derry School Board and the American Federation of State, County and Municipal Employees, Council 93/Local 1801 that calls for the following increases in salaries and benefits at the current staffing levels:

and further to raise and appropriate the sum of Twenty-One Thousand, Eight Hundred Seven Dollars and Seventy-Nine Cents (\$21,807.79) for the upcoming fiscal year, such sum representing the additional costs attributable to the increase in salaries and benefits required by the new agreement over those that would be paid at the current staffing levels in accordance with the most recent collective bargaining agreement? Pursuant to RSA 273-A:12, VII, if approved, the terms of this collective bargaining agreement, including the pay plan, but excluding cost of living increases, will continue in force and effect until a new agreement is executed.
